## ORDER U/S 12AA(1)(b)(i) OF THE INOCME TAX ACT, 1961

The aforesaid Trust/ Society / Company / Institution created / established under the Trust Deed / Memorandum of Association and is registered with the Asst. Registrar of Society, Nagpur on 08/02/2016 vide Reg. No. MAH/121 has filed an application for registration u/s 12AA of Income Tax Act, 1961 in Form No. 10A on 11/01/2016. After considering the material placed on record, I the undersigned, hereby register the Trust / Society / Company / Institution from A.Y. 2016-17 onwards.

- 02. The name of the Trust / Society / Company / Institution has been entered at URN 817/265/2015-16 as established for religious / charitable purposes, or as a general public utility in the Register of Trusts / Institutions maintained in this office.
- 03. However, no change in the Trust Deed Memorandum of Association shall be effected without the prior approval of the undersigned i.e. Commissioner of Income Tax (Exemptions), Pune.
- 04. This certificate testifies to the facts of registration u/s 12AA of the Income Tax Act, 1961 only. It does not confer any right or entitlement regarding operation of section 11, 12 & 13 or any other provisions of the Income Tax Act, 1961 which is to be decided by the Assessing Officer on merit.
- 05. In terms of Section 12AA(3), if the activities of the trust / institution are found to be not genuine or not being carried out in accordance with the objects of the trust / institution the registration granted vide this order shall be liable for cancellation.

The trust / Institution shall operate / open Bank account only in the name of the exempted entity and not in the name of any of the trustees / members / director.

- The Registration u/s 12AA of the Income Tax Act 1961, does not automatically exempt the income of the Trust. The registration u/s 12AA of the Income Tax Act 1961 does not confer any exemption u/s 80G & therefore, a separate application may be filed for grant of registration u/s 80G of the Income Tax Act 1961.
- 08. The Assessing Officer shall be at liberty to determine the taxability of Income of the Trust with reference to section 11, 12 & 13 of the Income Tax Act 1961, and to verify the genuineness of activities of the Trust / Institution in future.
